

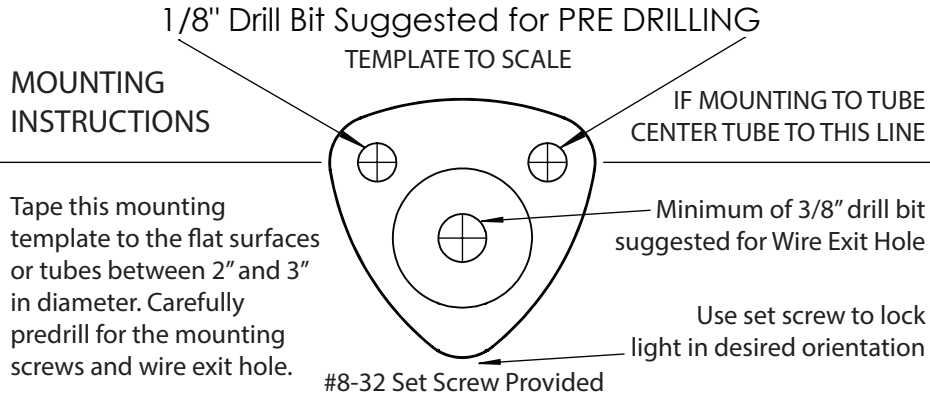

LED Tower/Spreader Light



Tape this mounting template to the flat surfaces or tubes between 2" and 3" in diameter. Carefully predrill for the mounting screws and wire exit hole.

Lights should be installed by a qualified professional. Fuse lights appropriately for amperage draw. Use standard SPST "on/off" switch.

If mounting to tubing, be sure to align the mounting screws along the center axis of the tube.

Secure mounting bracket with provided #10 self-drilling fasteners. Drill a minimum of 3/8" diameter wire exit hole. Run power wires through mounting bracket and push light / ball joint assembly into mounting bracket. Locate the light in your desired orientation and locks it position using the provided set screw.

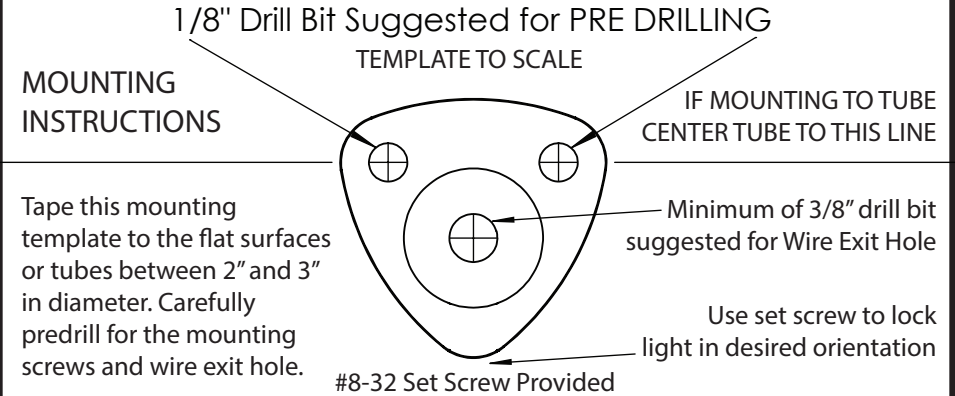
